All warranties commence on the date of delivery to the first retail buyer or date of first use, whichever is earlier.

Warranty applies only to defects in materials and workmanship discovered and reported to Coats Company, LLC within the warranty period specified above. The exclusive remedy for any breach of this warranty shall be the repair or replacement, at the option of Coats Company, LLC, of any defective part or parts, free of charge including labor per the above schedule, by the designated Coats Company, LLC Authorized Service Center. This warranty shall not apply when failure is caused by the purchaser's misuse, abuse, neglect, tampering, or by unauthorized alterations or repairs. Coats Company, LLC will not be responsible for loss of business or wages due to a product failure during the warranty period.

Air operated components must be supplied with clean, dry air. Failures due to air system contamination including, but not limited to water, rust, foreign debris are not covered. This warranty shall not apply to machines used in commercial applications in a production environment. This warranty excludes regular maintenance required in the ordinary use of the products specified above, including replacement of items, periodic machine calibration, and supplies ordinarily used up, consumed or worn out during normal use.
